- 6th St Bridge Consultation Lawrence/Mike
 - Review 6th St Bridge project status and how/what/when CVCCo can provide comments. Lawrence has had confirmation from Chris Davidson that there will be a public consultation period and he will also discuss timing for us to comment with City Councillors.
- BC 2021 Budget Process Transportation and Transit Standing Ctte
 - Letter submitted from CVCCo requesting increased funding for active transportation – including cycling infrastructure (attached at end). Thanks to Jude and Susan for compiling and editing.

Other Business

- Z-Maps updating & reprinting
 - Last paper Z Map project cost ~\$5000. Broken down roughly as \$1800 to design/build and \$3200 for printing. We cannot afford to do this without funding and utilizing existing mapping apps or online capabilities would provide easier updates and likely more users.
 - Mike to inquire as to how Google updates and how we can help them include bike routes in CV.
- Downtown Courtenay Business Improvement Assoc- Lawrence
 - Letter sent in regards to reopening and physical distancing in DT core.
 They have not requested any assistance wrt temporary bike/ped lanes downtown post COVID.
- Letter to Council re Connector Pathway Priority

 - Mike to add list of supporting groups and pdf all support letters to Dropbox so we can submit as directed by council for timing.
- Bike Shop Bouquets Chris/Jude
 - Bouquet was in Record recently.
- Cyclist Counts Lawrence
 - Comox will review performing automated cyclist counts on Lazo in next few weeks to update on prior counts.
 - May 14-25, 2015 traffic count on Lazo averaged 1,962 total per day with 768 bikes over 12 days (78 per day average or 4% of total count)
- Priority Routes in the Valley Mike
 - Strava Metro response from Strava indicates that CVCCo will not get access to Metro data. They are prioritizing government requests so Mike will try to follow up with City of Courtenay and see if they are willing to request the data so we can work with it. Could help with quantifying increase in cycling in CV.
- Condensary Road Concern Susan
 - MoTI are not making significant changes to bike lanes in portion near the campground. We will do our best to get upgrading of Condensary to be a priority.

- Farm Cycle Tour Lawrence/Chris
 - Some early communication some farms are asking if there will be a tour this year. We will wait and see if it goes and what they ask of us.
- Biannual Meetings with City of Courtenay Lawrence
 - Lawrence contacted Trevor Kushner (deputy CAO Courtenay) who offered to have spring/fall meetings with us and his staff to discuss projects/concerns, etc. Kyle Shaw is our public works contact who is providing good information.
- Guests Joining for Virtual "Zoom" Meetings Lawrence
 - Brian will email members to offer them to be observers to our Zoom meetings. They will have to email back to get the link and we will keep observers muted until a question period at end.
- Criminal Record Checks for Volunteers Mike
 - Mike will investigate whether CVCCo is registered to facilitate free criminal record checks for societies. He get a personal record check done to see how challenging or easy the process may be.
- Need for Additional Board Members Lawrence
 - Jude has possible interest from Rhonda Ryan. Rhonda will want to observe before committing, could not join us tonight.
- July Meeting Lawrence
 - Meeting set up for July 23 via Zoom.

Select Standing Committee on Finance and Government Services

On behalf of the Comox Valley Cycling Coalition and our members, I am submitting this letter to the Committee to bring to your attention our position on the need for a dramatic increase in provincial funding for active transportation including cycling infrastructure and safety.

The economic recovery from the pandemic provides an opportunity to support a low carbon future by building safe and linked cycle lanes throughout our community. A substantial increase to cycling infrastructure funding at the level laid out by Colin Stein of the BCCC (\$40 per capita) is needed to provide safe and connected cycling infrastructure in the Comox Valley.

We are observing and measuring the increase in cyclists through cycle counts and surveys. The new cycling infrastructure funded by Clean BC in the Comox Valley has provided the space for safe cycling in small areas and on a few routes. We can build on this success in the future by connecting these routes and expanding our safe cycling network.

In a small survey inquiring about cycling frequency since the onset of the pandemic, we received 50 responses. 60% of respondents are cycling more and 40% are cycling less. Reasons given for cycling more included: a feeling of increased safety with less traffic on the roads and wanting to avoid use of public transit due to the pandemic. Feeling safe continues to be a significant factor in the number and frequency of cycle trips. Bike sales, especially e-bikes, are up and more people are cycling. The province, regional districts and municipalities need to be cognizant of their responsibility to provide a safe environment on the shared roads to prevent injury and death for all road users.

Active transportation infrastructure is — by far — the most cost-effective category of transportation facility to build, in terms of both capital and operating costs. For the same cost of 4-6 km of new city roads, or 8km of 2-lane road widening, over 150 km of sidewalks, and 250 km of separated cycle tracks could be constructed.

In summary, a substantial increase in funding for safe multi-modal, linked pathways is part of a recovery which addresses lowering carbon emissions as well as the health and safety of our community.
